What is Assembly Bill 341?

On July 1, 2012, Governor Brown signed legislation AB 341, which requires that businesses that generate at least four cubic yards of waste per week, and multifamily complexes with five units or more, regardless of the amount of waste generated, have a recycling program in place. While California has been a national leader in solid waste diversion practices, many recyclables still end up in the landfill. Therefore, the law is designed to reduce greenhouse gas emissions by diverting waste from landfills and to help reach California's recycling goal of 75 percent by the year 2020.
