ANDERSON LANDFILL & ANDERSON-COTTONWOOD DISPOSAL

FIRE DEBRIS DISPOSAL

Anderson Landfill is authorized by the Central Valley Regional Water Quality Control Board and the Shasta County Health and Human Services Department (LEA) to accept non-hazardous waste fire debris.

ACCEPTED DEBRIS

- Ash & Dirt
- Concrete
- Construction/Demolition Debris
- Non-Friable Asbestos— bagged and delivered separately
- Friable Asbestos – bagged and delivered separately (pending)
- Household Furniture
- Metal – separated for recycling
- Outbuildings
- Trees & Vegetation

MANDATORY DEBRIS PROFILE

All fire-related loads not handled by CalRecycle Debris Removal Program must be accompanied by a WM Solutions Profile.

If you choose to opt out of the CalRecycle program, please ensure that you or your hired contractor complete a debris profile form. The profile form is available at wmsolutions.com. (See reverse for detailed instructions)

Anderson-Cottonwood Disposal will complete the form for you if you opt out and you or your contractor order debris boxes through Anderson-Cottonwood Disposal.

LANDFILL HOURS OF OPERATION (During Cleanup)

7 a.m. – 7 p.m. Monday – Saturday

The Anderson Landfill has a lined, Subtitle D cell with immediate capacity to accommodate the estimated 200,000 cubic yards of fire debris. The life of this regional landfill is estimated at 60 years, providing a safe and sustainable solution for the Carr Fire cleanup effort.

OPT-OUT/NON-FEMA FUNDED HAULING SERVICES

Anderson-Cottonwood Disposal is the franchised hauler for unincorporated Shasta County. It can provide debris boxes, hauling and disposal to property owners who opt-out or are not eligible for FEMA-funded cleanup. **It will also secure the mandatory debris profile for fire-generated waste disposal.**

SCHEDULING A DEBRIS BOX

- 1. Secure Demolition Permit** from the appropriate jurisdiction: City of Redding or Shasta County
- 2. Complete Opt-Out Permit** – available online at ShastaReddingRecovers.org.
- 3. Schedule a Debris Box** – Call 1-800-8101 (Option 4)
- 4. Submit Demolition & Opt-Out Permits** – Send permits to Anderson-Cottonwood Disposal by emailing rclark21@wm.com or mailing to Anderson-Cottonwood Disposal, 8592 Commercial Way, Redding, CA 96002



DISPOSAL PROFILE INSTRUCTIONS

Customers opting out of the CalRecycle Debirs Removal Program who are self-hauling or using a contractor other than Anderson-Cottonwood Disposal must submit a debris profile via <http://www.wmsolutions.com>. If you have never used this website before, you will need to click on "register" in the upper righthand corner and create an account.

Once registered, you will automatically be logged into our system and you should see a green button to create a profile online.

When you click the green button, our website will ask you for the state where you will dispose material.

To the right, please select the blank EZ profile and complete online.

The next few screens will ask you for the generator, customer and material information, which will need to be filled in to advance to the next screen.

Please remember to indicate in the Process Generating section that the material is coming from the fire cleanup and attach the Opt-out form and Demolition permit to make the approval process quicker.

Please also note whether this came from a permitted structure or unpermitted structure.

After answering all the required questions, (red asterisk) you will reach a page that requires a signature to submit your profile online.

Once you have submitted (and you receive confirmation), our website will email you a pricing document, which will need to be reviewed, signed and returned to complete the approval process. *(The process typically takes between 1 to 2 days.)*

Landfill disposal cost will be in addition to the profile charge.
