1 GENERAL

30 TAC §330.59(a)(1)

The Skyline Landfill is an existing Type I Municipal Solid Waste Disposal Facility (Permit No. MSW 42C) owned and operated by Waste Management of Texas, Inc. (WMTX). The Skyline Landfill is located in Dallas and Ellis Counties, Texas and provides waste disposal capacity for residences and businesses in Dallas and Ellis Counties and surrounding Texas counties. WMTX proposes to increase the remaining permitted disposal capacity of this facility via a horizontal expansion. The expansion of Permit No. MSW 42C is submitted by this permit amendment application as Permit No. MSW 42D.

This application has been prepared consistent with 30 Texas Administrative Code (TAC) Chapter 330 Municipal Solid Waste Management Regulations (MSWMR) adopted by the Texas Commission on Environmental Quality (TCEQ), effective March 27, 2006 and May 29, 2008.

Part I of this permit amendment application contains information about the site and the applicant as required in 30 TAC §§281.5, 305.45, and 330.59. Part II of the permit amendment application describes the existing conditions and character of the facility and surrounding area as required in §330.61. Part III of the permit amendment application presents engineering information, detailed investigative reports, the schematic designs of the facility, and the required plans as required in §330.63. Part IV of the permit amendment application contains the Site Operating Plan, which includes specific information regarding the daily operations of the site as required in §330.65.

1.1 Permit History

11

The Skyline Landfill was originally permitted by the State of Texas in 1976 as Permit No. MSW 42. Trinity Valley Reclamation was issued a permit amendment by the Texas Department of Health (Permit No. MSW 42A) in 1979 with a permit boundary of approximately 73 acres. The facility was acquired by WMTX from Trinity Valley Reclamation in 1987. Permit No. MSW 42C was issued on April 18, 1995, which expanded the landfill to a permit boundary of 666.95 (667) acres. The Skyline Landfill is currently operating under the 1995 permit requirements and any subsequent modifications or authorizations.

1.2 Supplementary Technical Report

The Skyline Landfill is an existing 666.95-acre (667 acres), Type I municipal solid waste disposal facility owned and operated by Waste Management of Texas, Inc. (WMTX). The Skyline Landfill is located in Dallas and Ellis Counties, on the north side of the city of Ferris within the city limits of Ferris, Texas and west of Old U.S. Highway 75 (Business IH 45). The Skyline Landfill provides waste disposal capacity for residences and businesses in Dallas and Ellis Counties and surrounding Texas counties.

The current permitted Skyline Landfill consists of a permit boundary of about 667 acres. The area within the permit boundary consists of 286.4 acres of permitted waste disposal footprint (Phase 1, 2, 3, 4, and 5), 68.3 acres of Pre-Subtitle D area with final cover constructed, and 312.3 acres of buffer and other areas. The waste disposal footprint includes approximately 146.5 acres of active waste disposal area and approximately 139.9 acres of future disposal area. There are approximately 68.3 acres of Pre-Subtitle D area that have received final cover and will not accept any additional waste. The remaining site is currently active and all future development is under Subtitle D standards and requirements.

The permit amendment application will reduce the current permit boundary by 5.21 acres. The Skyline Landfill proposed permit boundary is 661.74 (662) acres. The proposed landfill expansion will remove approximately 20.1 acres and add approximately 22.3 acres of waste footprint for a net increase of 2.2 acres of waste disposal footprint. The maximum final contour elevation will remain at 688 feet-msl, and the permit boundary will remain at approximately 667 acres. The waste disposal footprint will be increased to approximately 284.4 acres for Phases 1, 2, and 3. The Phase 4 designation will not be used for phases with this expansion. Phase 5 consists of 4.2 acres.

Locations outside the permitted waste disposal areas that are used for buffer distance between waste disposal areas and the permit boundary include entrance facilities, a Type IX Beneficial Landfill Gas Recovery Facility (Type IX Registration No. 48018), a citizen's convenience center, a leachate storage facility, a mud grate facility, a maintenance facility, access roads, and surface water drainage facilities. Waste processing and storage facilities located within the waste disposal footprint include a

large item storage area, a construction and demolition recycling and re-use area, a liquid stabilization area, and a bioremediation treatment pad. There are two easements through the facility being Lone Star Gas and TU Electric, neither of which impact the development or operations of the facility.

The proposed landfill expansion will result in a remaining waste disposal capacity of approximately 53,505,000 cubic yards of waste and daily/intermediate cover, or approximately 41,198,850 tons of waste capacity, based on the March 4, 2012 aerial topography.

The Skyline Landfill receives approximately 1,040,000 tons annually (approximately 3,333 tons per day). The waste acceptance rate will vary over the life of the facility depending on market conditions. WMTX anticipates the maximum rate of waste disposal to be approximately 1,622,740 tons per year (approximately 5,200 tons per day). Based on the current waste acceptance, the facility will have an approximate site life of 33 years.

2.1 Location Description

The Skyline Landfill is an existing Type I Municipal Solid Waste Disposal Facility located in Dallas and Ellis Counties, Texas. The Skyline Landfill is located on the north side of the City of Ferris within the city limits of Ferris, Texas and west of Old U.S. Highway 75 (Business IH 45). The eastern site boundary coincides with the west line of the Southern Pacific Railroad right-of-way.

The facility is located at 1201 N. Central Avenue, Ferris, TX 75125.

2.2 Access Routes

The main public roadway providing access to the facility is Old U.S. Highway 75 (Business IH 45). The site access road is constructed of reinforced concrete and varies in width from 30 feet to 43 feet for the first 500 feet from Old U.S. Highway 75. The remainder of the road (approximately 1,700 feet) is reinforced concrete, and is 24 feet in width with 3-foot asphalt shoulders on each side, for a total width of 30 feet.

The Skyline Landfill is owned and operated by WMTX, a wholly owned subsidiary of Waste Management, Inc. (WM), a Delaware Corporation based in Houston, Texas, whose shares are publicly traded on the New York Stock Exchange. WM is an international supplier of solid waste management services and specializes in collection, transfer, disposal, recycling, and other waste management services provided to municipal, commercial, industrial, and residential customers. WMTX has operated municipal solid waste facilities in Texas since 1980. The Skyline Landfill was acquired by WMTX in 1987. The facility currently operates under TCEQ Permit No. MSW 42C, issued on April 18, 1995.
