



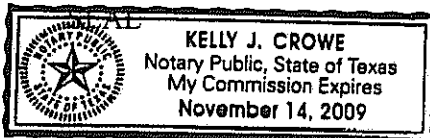

APPLICATION AND PRELIMINARY DECISION. Cougar Landfill, Inc. (A Waste Management Company), 820 Gessner Road, Suite 940, Houston, Harris County, Texas, has applied to the Texas Commission on Environmental Quality (TCEQ) for a permit modification to update the Cougar Landfill (Type IV Landfill) Site Operating Plan. The facility is located at 8601 East Mount Houston Road, Houston, Harris County, Texas. This application was received initially by the TCEQ on December 18, 2007, and includes follow-up revisions to the application, received on March 18, 2008, and May 13, 2008.

The TCEQ executive director has completed the technical review of the application and has prepared a draft permit modification. The draft modification, if approved, would establish the conditions under which the facility must operate. The executive director has made a preliminary decision that this permit modification, if issued, meets all statutory and regulatory requirements. The permit modification application is available for viewing and copying at the TCEQ Region 12 Office, located at 5425 Polk Street, Suite H, Houston, Texas 77023-1452. PUBLIC COMMENT. You may submit public comments about this application. Written public comments must be received in the Office of the Chief Clerk, MC 105, TCEQ, P.O. Box 13087, Austin, TX 78711-3087 within 23 days after the date this notice was mailed. After the deadline for public comments, the executive director will review and consider the comments. The executive director is not required to file a response to comments. **If approved, notice of issuance will be mailed to everyone who submitted public comments or requested to be on the mailing list for this application. If comments are received, the mailing will also provide an explanation of the opportunity to file a motion to overturn the executive director's decision.**
