**Waste Management, Inc. Announces Group Senior Leadership Changes**  
*Frazier Appointed Senior Vice President*

**HOUSTON – June 21, 2007** – Waste Management, Inc. (NYSE: WMI) today announced Brett Frazier was promoted to senior vice president of the Eastern Group, which encompasses 15 states in the Eastern U.S. He succeeds James E. Trevathan who has assumed the role of senior vice president of the 12-state Southern Group following the retirement of David R. Hopkins, who is retiring after more than 25 years in the waste industry.

“Brett Frazier has 25 years of operational experience in our industry, including leadership positions focused on operations improvement that have given him an excellent understanding of the dynamics at play in our operations,” said Larry O’Donnell, president and chief operating officer of Waste Management. “Most recently, he has led operations excellence efforts including our technology enhancements to improve our operations and the delivery of our service to our customers.

Frazier joined Waste Management in 2000. He was promoted to vice president of collections operations support after serving as vice president of operations improvement. Before that time, Frazier was market area general manager of the Houston metro area, which under his leadership was recognized in 2005 with the company’s highest honor for operational performance. Before joining Waste Management, he spent 19 years in the industry and has held operational, sales and management positions in Texas, California and Arizona.

Dave Hopkins’ career spans more than a quarter century in the solid waste industry. He came to Waste Management in 1998, and most recently he has been the leader of the Southern Group. Before that role, he served as CEO of the company’s international business that had operations in 21 countries.
