Recyclable Material Definitions for acceptance

Altered or Shredded Tires: Whole tires must be mechanically shredded, quartered, baged, de-sidewalled, or baled. Oversized tires must be quartered.

Clean Dirt: Granular soil such as clay, sand, or silt that breaks apart when handled by light duty construction equipment such as a small backhoe or skip loader. No trash, excessive metal, wood, roots, or grass contaminants. Loads with significant quantities of grass and/or root contamination will be rejected. Loads with excessive rock, concrete, or asphalt will be charged as "Mixed Inert" as described below. Clean dirt greater than 10 cubic yards or come from an industrial location require pre-approval.

Clean Concrete: Any combination of rock, concrete, gravel, or brick, which is less than 24 inches in any 2 dimensions. Loads containing debris exceeding this size limitation will be charged as mixed inert and disposed accordingly. Loads greater than four (4) feet in any dimension may be assessed an additional handling fee (hard-to-handle fee). Concrete debris should have minimal re-bar protruding from the individual pieces of concrete. No trash, excessive metal, wood, roots, or grass contaminants. Loads with significant quantities of grass and/or root contamination will be rejected. Loads with soil content greater than 10% will be charged as "Mixed Inert" as described below. Material greater than 500 tons or from an industrial location require pre-approval.

Clean Asphalt: Asphalt, or asphalt grindings which is less than 24 inches in any 2 dimensions. Loads containing debris exceeding this size limitation will be charged as mixed inert and disposed accordingly. Loads greater than four (4) feet in any dimension may be assessed an additional handling fee (hard-to-handle fee). No trash, excessive metal, Petromat, wood, roots, or grass contaminants. Loads with significant quantities of grass and/or root contamination will be rejected. Loads with soil content greater than 10% will be charged as "Mixed Inert" as described below. Material greater than 500 tons or from an industrial location require pre-approval.

Mixed Inert: Any combination of Clean Dirt, Clean Asphalt, or Clean Concrete (as described above). No trash, excessive metal, wood, roots, or grass contaminants. Loads with significant quantities of grass and/or root contamination will be rejected. Material greater than 500 tons or from an industrial location require pre-approval.

Industrial Material: Includes, but is not limited to, all non-Asbestos projects greater than 500 tons or material generated from an industrial location. Industrial & soil waste requires pre-approval: Inert soil, industrial soil, industrial process wastes, asbestos containing waste, inert sludge, and debris require pre-approval prior to delivery and acceptance. Loads not pre-approved will be rejected.

Personal Protective Equipment (PPE) is required at all times: High Visibility Vest and Hard Hat.
