## Too Hot & Hazardous to Handle

Toxic, flammable, combustible, and corrosive items are considered hazardous waste and should never be placed inside curbside carts. Improper disposal of household hazardous waste puts collection drivers, your community, and the environment at risk. Learn why these materials require special handling—and how you can help keep curbside collection safe for everyone.

### A Dangerous Mix



Households dispose of a variety of waste materials curbside every day. When items like batteries, hot coals, ashes, cleaners, and other flammable or reactive products end up in the cart, they can spontaneously ignite or trigger dangerous chemical reactions—putting waste collection crews, your community, and the environment at risk.

### Small Mistakes, Big Impact



Household hazardous waste should never be poured on the ground or into storm drains, sewers, or waterways. These pathways can carry toxic chemicals far from where they were dumped—polluting groundwater, harming ecosystems, and threatening drinking and irrigation supplies.

### Finding The Right Solution



To safely dispose of hot coals and ashes, ensure they are completely extinguished before placing them bagged in the trash. For batteries, light bulbs, electronic waste, paints, cleaning supplies, and yard products, please take them to one of our local transfer station facilities. ## Safe In - Safe Out:

Setting out carts properly makes it safer and quicker for our drivers to service your residence. Please follow these simple rules when setting out your curbside carts:

- Keep carts at least three feet away from parked cars.
- Keep access to carts clear of any obstructions.
- Keep lids closed to prevent windblown litter and avoid overage charges. Bins and carts overfilled by 12 inches or more above the rim may result in additional charges per incident.
