AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN, STATE OF CALIFORNIA ESTABLISHING THE SCHEDULE OF RESIDENTIAL SOLID WASTE COLLECTION CHARGES IN RESIDENTIAL NON-TAX ROLL BILLED ZONE 3 FRANCHISE AREAS 3, 19, 38, AND 43 FOR FISCAL YEAR 2024-2025

THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN ORDAINS AS

Section 1. This Ordinance, which shall take effect and be in full force on and after the 21st day of June, 2024, shall have a summary published in accordance with the provisions of Government Code Section 25124(b)(1).

Section 2. Findings and Determinations.

- 1. Kern County Ordinance Code Section 8.28.060 requires that, except in any universal collection area, all properties must arrange for solid waste disposal services by either employing the services of a franchise hauler or by providing such disposal services themselves (self-haul).
- 2. A written Report containing a description of each residential parcel of real property subject to solid waste collection in Residential Non-Tax Roll Billed Zone 3, Franchise Areas 3, 19, 38, and 43 and receiving collection services and the amount of the charge for services for each parcel for Fiscal Year 2024-2025 has been prepared by the Public Works Department and filed with the Clerk of the Board of Supervisors.
- 3. Prior to the adoption and approval of the Report, a properly noticed hearing has been held, all objections or protests heard, considered and ruled upon.
- 4. At the conclusion of the hearing and concurrently with this Ordinance, the Report, including the findings and charges for service were approved and adopted by this Board.
- 5. This Board hereby certifies that these rates are set in full compliance with the provisions of Proposition 218.
- <u>Section 3.</u> Solid Waste Collection Charges for Fiscal Year 2024-2025 for Residential Non-Tax Roll Billed Zone 3 Franchise Areas 3, 19, 38 and 43.
- 1. Pursuant to Kern County Ordinance 8.28.060 and 5.36.090, the schedule of Solid Waste Collection Charges for Zone 3 Franchise Areas 3, 19, 38, and 43 for Fiscal Year 2024-2025 is hereby established as per Exhibit A.
- <u>Section 4.</u> If any clause, provision, sentence, or paragraph of this Ordinance, or the application thereof, is deemed to be invalid as to any person, entity, establishment or circumstance, such invalidity shall not affect the other provisions of this Ordinance which still remain in effect, and to its end, it is hereby declared that the provisions of this Ordinance are severable.
- Section 5. At a properly noticed Public Hearing, the Kern County Board of Supervisors (Board) may approve future rate adjustments based on the prior fiscal year Consumer Price Index (CPI) for all Urban Consumers, Garbage and Trash Collection (Series ID: CUUR0000SEHG02) without a protest hearing for four additional years. If, in any year, the rate adjustment approved by the Board is lower than the amount resulting from the application of the CPI, the difference may be carried over and applied by the Board to future rate adjustments. In the event the cited index is substantively changed or is no longer published, the Board will select a substantially similar index.

<u>Section 6.</u> The schedule of Solid Waste Collection Charges shall become effective July 1, 2024.

Section 7. This Ordinance shall supersede and replace Kern County Ordinance G-9220.
