AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN, STATE OF CALIFORNIA ESTABLISHING THE SCHEDULE OF UNIVERSAL SOLID WASTE COLLECTION CHARGES IN THE EASTERN KERN UNIVERSAL COLLECTION AREA FOR FISCAL YEAR 2024-2025 AND PROVIDING FOR THE COLLECTION OF THE SAME ON THE TAX ROLL

THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN ORDAINS AS FOLLOWS:

Section 1. This Ordinance, which shall take effect and be in full force on and after the 21st day of June 2024, shall have a summary published in accordance with the provisions of Government Code Section 25124(b)(1).

Section 2. Findings and Determinations.

- 1. The Eastern Kern Universal Collection Area was established pursuant to Kern County Ordinance 8.28.081 and designated by the Board of Supervisors as an area where solid waste collection services are required for all properties, except vacant land or uninhabitable properties.
- 2. A written Report containing a description of each parcel of real property subject to universal solid waste collection in the Eastern Kern Universal Collection Area and receiving collection services and the amount of the charge for services for each parcel for Fiscal Year 2024-2025 has been prepared by the Public Works Department and filed with the Clerk of the Board of Supervisors.
- 3. Prior to the adoption and approval of the Report, a properly noticed hearing has been held, all objections or protests heard, considered and ruled upon.
- 4. At the conclusion of the hearing and concurrently with this Ordinance, the Report, including the findings and charges for service were approved and adopted by this Board.
- 5. This Board hereby certifies that these rates are set in full compliance with the provisions of Proposition 218.
- <u>Section 3.</u> Establishment of Universal Solid Waste Collection Charges for Fiscal Year 2024-2025 for the Eastern Kern Universal Collection Area.
- 1. Pursuant to Kern County Ordinance 8.28.084, the schedule of Universal Solid Waste Collection Charges for the Eastern Kern Universal Collection Area for Fiscal Year 2024-2025 is hereby established in Exhibit A.
- Section 4. Collection of Charges on the Tax Roll. In accordance with the provisions of California law and Kern County Ordinance 8.28.084, this Board hereby approves and provides that the charges herein provided for shall be placed on the tax roll and collected at the same time and in the same manner as property taxes for Kern County. The Clerk of the Board of Supervisors is directed to file with the Auditor-Controller-County Clerk a copy of this Ordinance. The Clerk is further directed to include an endorsed statement that the Ordinance has been approved and adopted by the Board of Supervisors. The Auditor-Controller-County Clerk is directed to enter the amounts of the service charges against the respective lots or parcels as they appear on the current assessment roll.
- <u>Section 5.</u> If any clause, provision, sentence, or paragraph of this Ordinance, or the application thereof, is deemed to be invalid as to any person, entity, establishment or circumstance, such invalidity shall not affect the other provisions of this Ordinance which still remain in effect, and to its end, it is hereby declared that the provisions of this Ordinance are severable.

Section 6. At a properly noticed Public Hearing, the Kern County Board of Supervisors (Board) may approve future rate adjustments based on the prior fiscal year Consumer Price Index (CPI) for all Urban Consumers, Garbage and Trash Collection (Series ID: CUUR0000SEHG02) without a protest hearing for four additional years. If, in any year, the rate adjustment approved by the Board is lower than the amount resulting from the application of the CPI, the difference may be carried over and applied by the Board to future rate adjustments. In the event the cited index is substantively changed or is no longer published, the Board will select a substantially similar index.

<u>Section 7.</u> The schedule of Solid Waste Collection Charges shall become effective July 1, 2024.

<u>Section 8.</u> This Ordinance shall supersede and replace Kern County Ordinance G-9213.
