Additional Carts

Need additional carts? Tulare County residential customers who regularly generate excess organics and/or trash, can request additional 96-gallon carts for a monthly charge.



Household Hazardous Waste (HHW)

WM will not collect household hazardous waste (HHW) - State law prohibits the disposal of hazardous materials and electronic devices in your recycling, organics or trash containers.

Hazardous waste includes most paints, pesticides, petroleum derivatives such as motor oil and solvents, electronic devices such as cathode ray tubes (as in TV and computer monitors), LCDs and plasma screens. Other items banned from disposal include batteries, thermostats, computers, telephones, answering machines, radios, stereo equipment, tape players/recorders, phonographs, video cassette players/ recorders, calculators, aerosol cans, fluorescent lights, and specific mercury-containing devices.

If these items are identified in your containers, your cart will be tagged and not collected.

2025 Residential Waste and Recycling Service Guide



Proud to Serve Tulare County

WM and Tulare County are proud to present this updated service guide to your residential recycling, organics, and trash collection services to comply with California State Senate Bill (SB) 1383.

Residential Cart Service

Starting the week of April 1, 2025, residential customers in the Valley Floor service area will receive weekly trash, recycling, and organics collection and residential customers in the Foothill service area will receive weekly trash and organics collection and every other week recycling collection. A listing of which items may be placed in each container is noted in this guide and instructions for placing the containers out for service are on the lid of each cart.

Don't have a recycling and/or organics (yard waste) cart? Depending on the containers you need, on or after March 10, 2025, you will receive one (1) 96-gallon recycling cart and/ or one (1) 96-gallon organics cart if you do not already have a cart or services (unless your address is located in the waived portion of the Foothill service area).

Container Color Transition

California regulations under State Senate Bill (SB) 1383 require collection container colors to be uniform across the state by 2036. In Tulare County, the new cart color scheme will be as follows: recycling carts will have a blue lid, organics waste carts will have a green lid, and trash carts will have a black lid. While new carts will be delivered in this color scheme, existing carts will be transitioned gradually over time to minimize service disruptions. Make sure you check the lid or label for instructions on using your carts correctly and avoid contamination.

Holidays

WM observes the following holidays:

If a holiday falls on a weekday, collections for the rest of the week will be delayed by one day. For example, for a Thursday holiday, service would be completed on Friday, and Friday service would be completed on Saturday. For holidays that fall on a Saturday or Sunday, there are no delays.

Service Reminders

- Place all items in the appropriate container and close the lid to fit tight to the cart body. Trash, organics, and recyclables placed outside the cart will not be collected. Place your carts at the curb by 6 a.m. on collection day. After service, carts should be removed from the curbside.
- Roll carts to the street and place them against the curb (if possible) with the handles facing your home. Place carts at least three feet apart from other carts and objects.





Events

WM provides three bulky item collection events for Tulare County residential customers throughout the year. For upcoming dates and locations, please visit home.wm.com/tulare.

Acceptable bulky items Include furniture (chairs, mattresses, sofas), appliances (dishwasher, microwave), electronic waste (TVs, computers), area rugs.

Non-acceptable items are household hazardous waste, or HHW (such as paint, oil and batteries), tires, spas, pianos, vehicle parts, items requiring more than two people to safely handle.

Christmas Tree Collection

Tulare County residential customers can recycle real unflocked Christmas trees and wreaths during the first two service days following December 25 at no additional charge. Trees longer than six (6) feet must be cut in half. Please remove all decorations, including tinsel, lights, ornaments, and tree stands.
