MANDATORY SINGLE-FAMILY DWELLING (Residential) SOLID WASTE SERVICE EXEMPTION



Trash (solid waste) removal service is mandatory for all residents in Carson City. Unless otherwise requested, residential customers will be provided the standard service level (96-gallon solid waste, 96-gallon recycling, and 96-gallon yard waste) carts at \$18.33 per month, which is billed quarterly in advance. Customers may opt out of recycling and yard waste service but doing so will not result in a reduced rate. It is the customer's responsibility to contact Waste Management at (775) 343-7596 to request changes their services.

Customers who routinely self-haul their trash (solid waste) to the Carson City Landfill on Flint Drive may apply for an exemption from mandatory collection service by providing their original landfill receipts for the twelve (12) <u>consecutive</u> months leading up to their application date in addition to this signed application. Photocopies of receipts will not be accepted.

Applications must be submitted to the Waste Management office at 5560 Sheep Drive, Carson City, NV 89701. Records will be kept on file at this location.

No credits or refunds will be given to customers for months of overlapping collection service and landfill use.

To maintain a service exemption, residential customers must provide original landfill receipts for the consecutive twelve (12) month period on or before the anniversary of their initial exemption. In the event a customer does not provide appropriate documentation, a 96-gallon solid waste cart, 96-gallon recycling cart and 96-gallon yard waste cart will be delivered to the customer's address. An activation fee (\$52.42) will be charged in addition to the current monthly rate, which will be billed quarterly in advance. Exemption application guidelines as excerpted below are set out in section 8.4 of the franchise agreement with Waste Management, which was approved by the Carson City Board of Supervisors on December 20, 2018. Regular waste removal helps to ensure the health and safety of our community. Residential customers should not apply for this exemption unless they are sure that they will haul material to the landfill at least one (1) time per month.

8.1 MANDATORY SFD SERVICE EXEMPTION

SFD Customers able to demonstrate landfill usage through the provision of monthly landfill receipts from the previous six (6) calendar months in year one of the Agreement and from the previous 12 calendar months in each subsequent Agreement Year may request an exemption from mandatory SFD Service. A request form shall be provided by the CONTRACTOR at the request of a resident. The completed form shall be submitted by the resident, with required documentation, to the CONTRACTOR

for review. The CONTRACTOR shall include a list SFD Service exemption requests, including the name of the resident, the address, whether the request was approved or denied, and reason for denials, if any, in each quarterly report.
