Curbside Carts: How WM Containers Enhance Waste Collection



Maximizing Efficiency at Every Collection

WM-provided carts are designed for efficient collection, allowing our trucks to securely grip sides, harness gravity to open the lids, and unload contents without generating litter (unless carts are overfilled). These carts help drivers service customers quickly and reduce delays. Best of all, WM replaces worn-out carts at no additional cost. Customer-owned carts are not repaired or replaced by WM.



Prioritizing Safety

WM carts are also safer than the consumer-grade containers found in hardware stores. With WM-provided carts, our drivers are not exposed to the diverse range of waste items that people dispose of. Their design allows our drivers to use truck arms for collection, minimizing direct contact with waste. This reduces exposure to potentially hazardous materials and ensures a safer service.



Caring for our Planet

WM carts are built for durability. They withstand harsh weather and rough handling—such as dragging, heavy pressure, and drops. This longevity reduces the need for frequent replacements, lowering costs and decreasing the demand for resources needed to manufacture new carts. By using a WM cart you are helping enhance collection and build a more sustainable Lyon County.

If your WM cart is damaged, contact customer service to request a replacement. WM offers one replacement of a WM cart per year at no additional charge.
