SB1383: DOES IT AFFECT YOU?

As you may know, SB1383 is a new state law that requires the separation of food scraps, food-soiled paper, and landscape trimmings from the trash. This will reduce the amount of organic material headed to landfills and create more opportunities to use it for compost.

While the law went into effect in 2022, Nevada City received an exemption due to the need for further outreach and a shortage of organic materials processing locations. However, residents and businesses are encouraged to keep food scraps out of the landfills.

We, at WM, are ready to help our community reach state goals and comply with state mandates. In the future, your organics cart will replace your yard waste cart, allowing you to dispose of organic materials such as landscaping trimmings and food scraps together.

Currently, Nevada County is upgrading the McCourtney Road Transfer Station to be able to transfer organic food mixed with food. You will receive plenty of notice before this change occurs. In the meantime, we encourage you to think of ways to reduce food waste at home. Please refer to the article here in the newsletter to keep updated on the renovation project.

Composting at Home and Reducing Food Waste

One way to keep food scraps out of the landfill is by composting at home. The UC Master Gardeners of Nevada County website (ncmg. ucanr.org) provies plenty of information on composting in your home. Use that compost to to grow your own food! Check out information at the Sierra Harvest website (sierraharvest.org). We encourage you to find ways to reduce food



waste and use outlets such as the Interfaith Food Ministry, and the Food Bank of Nevada County to donate excess food.

NEVADA CITY COMMUNITY CLEAN UP EVENT

SATURDAY, JUNE 3, 9 a.m. to 2 p.m., Eric W. Rood Administrative Center, Behind the Jail, off Cement Hill Road Nevada City.

Limit one full-size pickup truck (8ft bed): Upholstered furniture, mattresses, appliances, computers/monitors & eletronic goods, green waste (nothing over 4ft long and 1ft in diameter)

NO HAZARDOUS WASTE OR TIRES. NEVADA CITY RESIDENTS ONLY, NO BUSINESSES.

SUMMER SAFETY TIPS

Hot coals, batteries and small propane tanks can cause dangerous fires if not disposed of properly. Please follow these basic rules to protect our neighborhoods, equipment and employees safe.



HOT COALS

Make sure hot coals are fully extinguished before placing in the trash. Place in a metal container and drench in water and/or wait several days before placing in trash.

BATTERIES



Household batteries (C, D, AA, AAA, etc.) should be disposed of at a household hazardous waste disposal site or placed in a plastic bag and left on top of your recycling cart. Never place batteries in trash, recycling or organics carts.

Lithium batteries, most commonly found in cell phones and other electronic devices must be disposed of at a household hazardous waste facility. Lithium batteries are extremely dangerous and can cause high temperature fire flareups when crushed.



PROPANE TANKS

While convenient for a camping trip or a tailgate, small propane tanks can wreck havoc at a recycling facility, landfill or in the hopper of a collection truck. Please never place any type of propane tank in your trash, recycling or organics cart. These materials should be disposed of at a household hazardous waste facility.

MAKE YOUR PROPERTY FIRE SAFE

Reduce the risk of wildfires and protect your home and our community by ensuring your property is fire safe.

WM can help by hauling away your yard debris. All you have to do is sign up for curbside yard waste disposal and never worry about waiting in line at the McCourtney Road Transfer Station to drop off your green waste!
