

## WM Used Oil and Oil Filter Curbside Collection

You can recycle your used oil and oil filters without leaving home! WM offers free curbside used oil and oil filter recycling for customers subscribed to recycling collection service. It's as easy as 1-2-3-4.

1. Call WM at 530-274-3090 to order a free used oil container to dispose of your used oil.
2. Place used oil in provided container and used oil filter in a clear, sealable plastic bag. (Please note: Only oil is accepted. Mixed liquids will not be collected.)
3. Place provided container and clear, sealable bag next to your recycling container on your regularly scheduled collection day.
4. Sit back and relax as WM ensures your used oil and oil filter is properly disposed.

## Used Oil Drop Off Centers (Certified Collection Centers)

There are several locations throughout Nevada County that accept used oil and oil filters. These sites accept up to five gallons of used oil and xx used oil filters per visit. Please make sure your used oil and oil filters are properly stored in clear, sealable containers. Some sites even offer a 40 cent per gallon rebate! (Please note: Only oil accepted. Mixed liquids will not be accepted.)

## Used Oil & Oil Filter Recycling for Businesses

Any business generating household hazardous waste, including used oil and oil filters, must have a waste generator permit from Nevada County. Please contact Nevada County at 530-265-1222 for more information or mynevadacounty.com and enter "waste generator permit" in the search bar.

If your business generates **less than 27 gallons or 220 pounds** of household hazardous waste per month, you must make an appointment to dispose of materials at the McCourtney Road Transfer Station. Disposal is not free for businesses and does not include medical sharps. Please call customer service at 530-274-0120 to schedule an appointment.

If your business generates **more than 27 gallons or 220 pounds** of household hazardous waste, you may not use the McCourtney Road Transfer Station and instead must contact a hazardous waste disposal company.

## Other Hazardous Materials?

WM and Nevada County offer all residents free disposal of household hazardous waste (HHW) at the McCourtney Road Transfer Station. Never place household hazardous waste in any of your curbside containers.

## What Is Household Hazardous Waste (HHW)?

HHW are materials that are harmful if placed in a landfill or sent to a recycling center. These items include but are not limited to paints, household cleaners, pesticides, lightbulbs, batteries, electronics, pool chemicals, gasoline, and anti-freeze.

Residents can dispose of these items at McCourtney Road Transfer Station Wednesday through Sunday from 8 a.m. to 3:30 p.m. Please note: State law prohibits the transportation of more than 15 gallons or 125 pounds of household hazardous waste.

Items not accepted at the HHW site include asbestos, treated wood, sewage, explosives, ammunition, medications and compressed gas cylinders. (propane tanks and fire extinguishers accepted).

## Illegal Dumping

**Warning: Illegal Dumping Is Costly.**

Residents found to be dumping materials illegally can be cited for littering and face fines of up to **\$1,000 and six months in jail.**
