On behalf of USA Waste of Texas Landfills, Inc., Golder Associates Inc. (Golder) has prepared a Permit Amendment Application (PAA) for a proposed vertical and lateral expansion of the Hawthorn Park Recycling and Disposal Facility, located at 10550 Tanner Road, Houston, Texas 77041.

This facility is currently permitted by the Texas Commission on Environmental Quality (TCEQ) under Permit No. MSW-2185. This permit amendment, if approved, would be designated as Permit No. MSW-2185A. The facility is a Type IV municipal solid waste (MSW) facility and is authorized and will continue to accept brush, construction and demolition waste (C&D), and non-putrescible rubbish waste in accordance with TCEQ regulations. Putrescible waste will not be accepted at the facility.

The landfill footprint has been increased to include previously abandoned road right of ways been East, Center and West Blocks associated with Permit No. MSW 2185, an existing concrete recycling area, an existing compost operation, a closed landfill and an undeveloped tract been Center and East Blocks. The PAA proposes an increase to the landfill height.

The PAA is being submitted to TCEQ and is comprised of four parts designated as Parts I through IV. In accordance with 30 TAC §330.61(p), Golder is submitting Parts I and II of the application to H-GAC with this review request letter. We are requesting that H-GAC review the application for compliance with the H-GAC Regional Solid Waste Management Plan.
