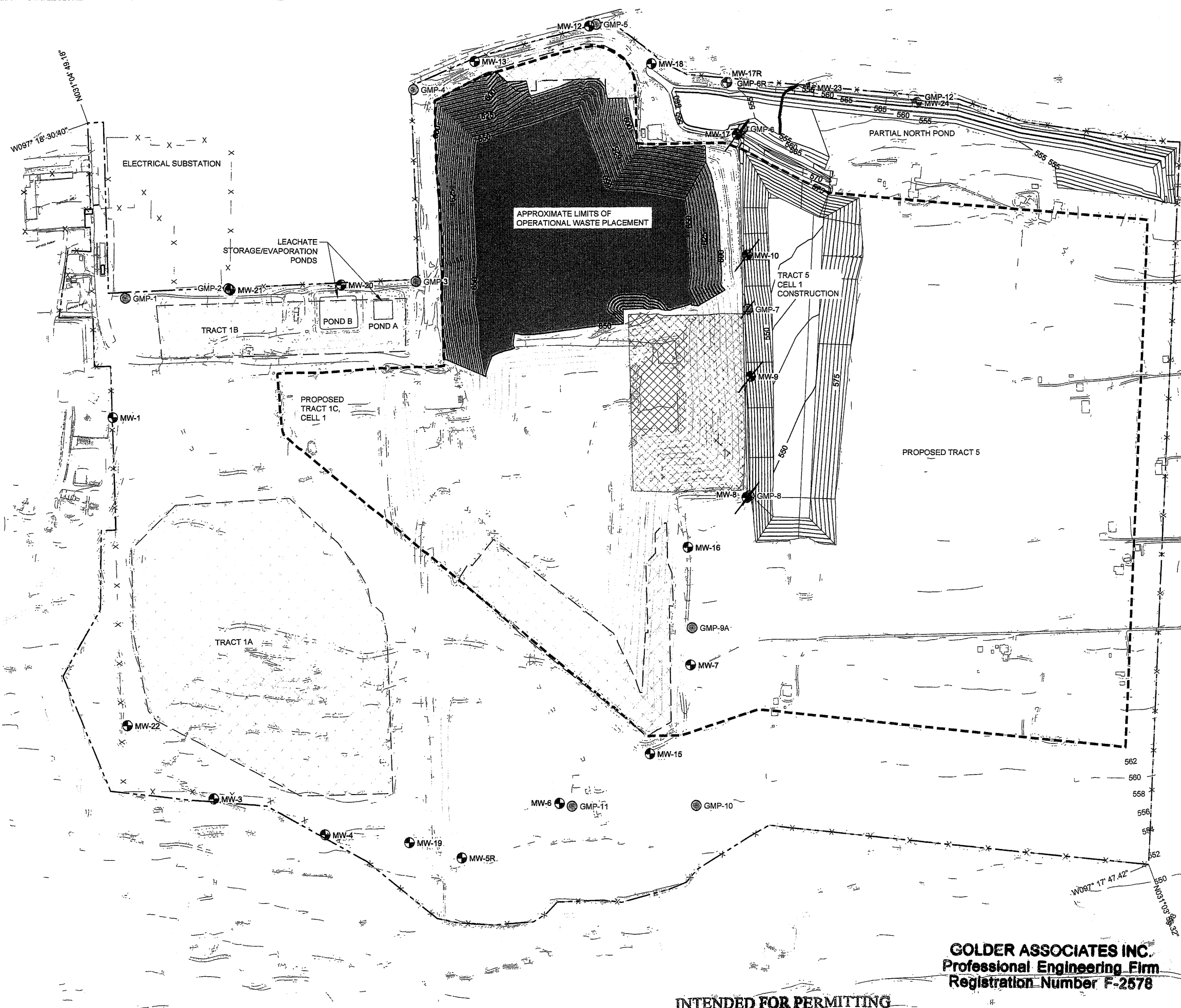

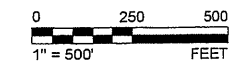

SEQUENCE OF LANDFILL OPERATION

1. CONTINUE WASTE PLACEMENT IN CONSTRUCTED LANDFILL CELLS.
2. CONTINUE CONSTRUCTION OF THE STORMWATER/SEDIMENTATION DETENTION PONDS.
3. CONSTRUCT LANDFILL CELLS AS REQUIRED FOR WASTE PLACEMENT IN AN EASTERLY DIRECTION.
4. PROVIDE INTERMEDIATE COVER AS FINAL GRADE IS REACHED AND IN AREAS WHERE RUNOFF DISCHARGES TO THE PERIMETER DITCH SYSTEM.
5. INSTALL ADDITIONAL MONITOR WELLS AS INDICATED IN ATTACHMENT 5 AND ADDITIONAL GAS MONITORING PROBES AS INDICATED IN ATTACHMENT 6.
6. INSTALL FINAL COVER IN AREAS WHICH WILL NOT RECEIVE ADDITIONAL WASTE.
